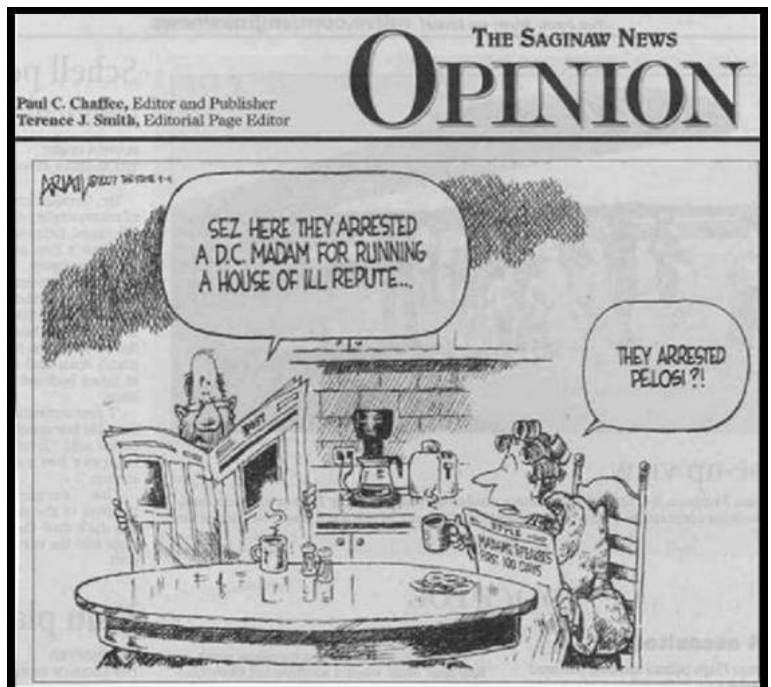

FROM THE "STRANGE AS IT MAY SEEM" CATEGORY/FOOD FOR THOUGHT FROM A DEMOCRAT PENNSYLVANIA STATE REP HARRY READSHAW

Harrisburg, April 7 – With the proposed plan to toll Interstate 80 rejected by the federal government thereby negating the possibility of increased State revenue, PA State Rep. Harry Readshaw today said that it is imperative that the PA legislature take a new look at the cost savings included in his proposed legislation that would prohibit illegal aliens from receiving State benefits. Readshaw stated, “The administration and the General Assembly must examine every means to gain revenues and cut expenses, and I believe that the impact on State funds by illegal immigrants should be in that mix.” Further, he cited a report by Daniel Stein, president of the Federation for American Immigration Reform which charged that Pennsylvania is spending nearly \$750 million on illegal immigrants annually and that in 2004 the taxpayers of Pennsylvania spent \$239.8 million on illegal aliens and their children in public schools.

Readshaw's proposal would mandate that anyone requesting public benefits, such as cash assistance, Medicaid or in-state college tuition assistance, would be required to sign an affidavit testifying that he or she is a citizen of the United States or a legal alien. Applicants also would have to provide identification and proof of residency,

Among other conditions: require public agencies to determine if people seeking benefits are lawfully in the country; require public employers and companies contracting with public employers to use electronic measures to verify a person's eligibility for employment; make it a felony to knowingly transport or harbor an illegal immigrant; authorize the state attorney general to reach an accord with the federal government to permit state and local law enforcement officers to assume certain federal immigration enforcement responsibilities. A survey found that 83 per cent of Pennsylvanians favored the State enforcing federal immigration laws that aren't currently being enforced and nearly 82 per cent believe that anyone receiving State benefits other than emergency medical care should have to show proof of citizenship. (We say,.....GO PENNSYLVANIA)

Michael Connelly, a retired Constitutional lawyer and Constitutional Law instructor in Carrollton, TX, regarding the health care bill. Excerpted from his stunning conclusions.....

I have read the entire text of proposed House Bill 3200: The Affordable Health Care Choices Act of 2009. I studied it with particular emphasis from my area of expertise, constitutional law. I was frankly concerned that parts of the proposed law might be unconstitutional. What I found was far worse than what I had heard or expected.

Much of what has been said about the law and its implications is, in fact, true. The law does provide for rationing of health care, particularly where senior citizens and other classes of citizens are involved, free health care for illegal immigrants, free abortion services, and probably forced participation in abortions by members of the medical profession.

The Bill will eventually force private insurance companies out of business, and put everyone into a government-run system. All decisions about personal health care will ultimately be made by federal bureaucrats, and most of them will not be health care professionals. Hospital admissions, payments to physicians and allocations of necessary medical devices will be strictly controlled by the government.

As scary as all that is, it just scratches the surface. In fact, I have concluded that this legislation really has no intention of providing affordable health care choices. Instead, it is a convenient cover for the most massive transfer of power to the Executive Branch of government that has ever occurred or even been contemplated. If this law or a similar one is adopted, major portions of the Constitution of the United States will effectively have been destroyed.

The first thing to go will be the masterfully crafted balance of power between the Executive, Legislative and Judicial branches of the U.S. Government. The Congress will be transferred to the Obama Administration authority in a number of different areas over the lives of the American people and the business they own.

The irony is that the Congress doesn't have any authority to legislate in most of those areas to begin with! I defy anyone to read the text of the U.S. Constitution and find any authority granted to the members of Congress to regulate health care.

NEW YORK TIMES: STEELE A "DISTRACTION" TO GOP DONORS AVOID RNC

Beleaguered Republican National Committee chief Michael Steele has become a 'distraction' as major party figures encourage others not to donate to the RNC but to candidates and committees directly instead.

Here are key excerpts from the Times article:

- "At a time when the Republican National Committee is looking to take advantage of Democrat troubles and make gains in Congressional elections, Mr. Steele is commanding attention mostly for questionable expenditures by the committees, lagging fund-raising, staff defections and dismissal, an aggressive round of paid speeches and speaking appearances and politically inopportune remarks."
- "That concern spiked as Mr. Steele fired his Chief of Staff, Ken McKay, a popular figure who, Republicans said, learned of his dismissal when his wife saw the report on MSNBC- implicitly blaming him for spending abuses, including the strip club that Mr. Steele said he had only learned about by reading the committee's report to the Federal Election Commission."
- "The chairman of the Republican Party should be able to lead," Alan Castellanos, an unpaid senior advisor to the committee, said in an interview. "And right now I think he's lost the confidence and support of the people he's leading."

LEGISLATIVE by Linda Jarrett

Some of you may already be aware of the comparison. This brief analysis certainly defines the main battle lines. We who are already engaged in fighting to take back our country need to recruit as many more citizens as possible - we will need everyone possible working to make the difference necessary in November—even if it's only an hour per week. Professor Joseph Olson of Hamline University School of Law, St. Paul, Minnesota, points out some interesting facts concerning last November's Presidential election:

- number of States won by: Obama: 19 McCain: 29
- Population of counties won by: Obama: 127 million McCain: 143 million
- Square miles of land won by: Obama: 580,000 McCain: 2,427,000

Olson adds: "In aggregate, the map of the territory McCain won was mostly the land owned by the tax paying citizens of the country. Obama territory mostly encompassed those citizens living in low income tenements and living off various forms of government welfare..." He believes that that the United States is now somewhere between a "complacency and apathy" phase of democracy with some forty per cent of the nation's population already having reached the "government dependency" phase.

If Congress grants amnesty and citizenship to twenty million criminal invaders called illegal and they vote, then we can say goodbye to the USA in few than five years. Pass this along to help everyone realize just how much is at stake. **Apathy is the greatest danger to freedom.**
