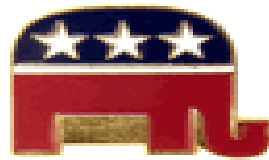
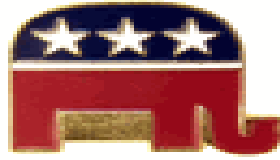

It has been said of obscenity that you can't specifically define it, but you "know it when you see it." Another phrase often used is, "if it looks like a duck and quacks like a duck, it's a duck." The same can be said of politics when tactics used are "un-American." Under our system of government, politicians and elected leaders discuss, debate, cajole, convince, trade votes, build alliances and coalitions, but they DO NOT BUY VOTES. This has recently been subverted when the last few votes needed to pass the Senate Health Care Bill were purchased.....yes, purchased from Senators Ben Nelson, Mary Landrieu and others in exchange for relief from payments for programs that other states will need to bear. While Nebraska will be relieved from expanding Medicaid costs, North Carolina (and other states) will be picking up the tab, all to ensure that a 1,700 page Health Care Bill, unread and misunderstood by many, would pass in a late night holiday eve vote. Americans know un-American political tactics when they see them, and, closing out 2009, we've surely seen the Obama administration's use of this distasteful means of passing ill-conceived and widely unsupported policy.

LEGISLATIVE REPORT by Linda Jarrett

As you all know, Health Care Insurance Coverage Access and health care costs were designated by the BHO administration to be "crises." Subsequently, the Senate and House were directed to rush their initial bills through Congress before Christmas. The Senate, after ramming through a frankly purchased vote on Christmas eve, has returned from its holiday recess – almost ONE MONTH later! Don't you find it curiously inconsistent for there to be such a big delay in the process of reconciliation in the face of such "crisis"?

For a summary of some of the FATAL FLAWS which remain – and will remain – in this disastrous legislation, please refer to the recent "Legislative Alert" (sent to you 1/8/10 – 1/9/10). Attached to it is contact information for the Senators and Representatives who are most likely to be influenced by our email or phone call.

Two "umbrella" comments for you to keep in mind as you fight this unprecedented Federal power grab are:

- what "Crisis"??? 85% of Americans like their health care. Only 5-6 million actually did not have access to insurance coverage.
- while the stated goals of the bill were to reduce costs and assure insurance coverage for the claimed 46 million people, if passed the costs are predicted to rise even more with at least 26 million identified as still not covered. At least 10 million are expected to join them as the result of expected cost increases.

Remember! This battle is not over! If we all work hard and given the recent cracks in the Democrat coalition of special interest groups, there is every reason to be hopeful of defeat.

As for other legislation, if the Health Care Bill is defeated, the odds against passage of "Cap & Trade" and "Card Check" increase dramatically. In an "end run" around Congress, the EPA is in the process of developing regulations that would essentially implement the anti-global warming goals stated at Copenhagen. This is yet another unconstitutional act by the BHO administration (in my lawyer's view). Preliminary investigation seems to indicate our ability to fight back during a "public comment" period during the process, and before issuance of the actual regulations. Hopefully, more definitive information and action guidelines will be available to you by the next newsletter.

The year 2010 promises to be an historic "water-shed" year. The future of our country as a prosperous representative republic depends on the action of people like us. Folks, PLEASE set aside some time (even an hour) each week to fight for the future of your children and grandchildren!
